

## **Probate Court Filing Costs**

### ***Overview of Initial Filing Fees***

*Note: Additional fees may be required based on the specifics of the case filed.*

*The following fees are required at the time of filing:*

#### **Probate of Will** (*Will being 5 pages or less\**)

- \$52.00 to: Morgan County Judge of Probate (includes three *Letters of Testamentary*)
- \$63.45 to: Hartselle Enquirer (must be on a separate check)

-\*plus, when applicable-

- \$3.00 Per page of Will over five pages  
(Example: 8-page Will would be... \$52.00 + \$9.00 = \$63.45)

also,

- \$4.00 Additional *Letters of Testamentary* (per copy)
- 

#### **Letters of Administration**

- \$52.00 to: Morgan County Judge of Probate (includes three *Letters of Administration*)
- \$63.45 to: Hartselle Enquirer (must be on a separate check)

**-MUST BE BONDED!!-**

- \$20,000.00 Minimum bond amount (Amount of bond is set based on personal property.)
- \$25,000.00 Minimum bond amount for potential wrongful death estates

also,

- \$4.00 Additional *Letters of Testamentary* (per copy)
- 

#### **Summary Distribution / Small Estate**

- \$52.00 to: Morgan County Judge of Probate (includes *Order Directing Summary Distribution*)
- \$63.45 to: Hartselle Enquirer (must be on a separate check)

Section 43-2-692(b)(1), Code of Alabama (1975), as amended, requires the State Finance Director to adjust annually the small estate value prescribed by this code section.

Currently, the qualifying amount is \$34,611.00 (or less) through February 29, 2024.

#### **Claim on Estate / Satisfaction of Claim**

- \$8.00 Claim (paid by person filing, not paid for by the estate)
  - \$11.00 Satisfaction of Claim – 1 page (paid by person filing, not paid for by the estate)
    - \$3.00 for each additional page
- 

#### **Inventory**

- \$11.00 For the first page, \$3.00 for each additional page

---

### **Final Settlement (Will or Administration)**

- \$5.00 to: Morgan County Probate Court (ten pages or less)
- also,
- \$3.00 per page of Final Settlement over ten pages

---

### **Adoption**

- \$82.00 to: Morgan County Probate Court
- also,
- \$25.00 New Birth Certificate (In State)
  - \$10.00 New Birth Certificate (Out of State)

Note: Additional filing fees will be figured after court hearing.

---

### **Name Change (Adult & Minor)**

- \$22.00 to: Morgan County Judge of Probate (includes 1 certified copy of the Decree)
- also,
- \$10.00 Drafting Fee, if you need Judge to prepare Decree

---

### **Guardianship, Guardianship and/or Conservatorship (Temporary, Permanent, or for a Minor)**

- \$27.00 to: Morgan County Judge of Probate (includes three Letters)
- also,
- \$4.00 Additional Letters of Guardianship and/or Conservatorship (per copy)
- plus, when applicable –
- \$25.00 Extension of Temporary Letters

Note: Additional filing fees will be figured after the court hearing(s)

### **Legitimation**

- \$22.00 to: Morgan County Judge of Probate

### **Marriage License Correction (license issued prior to August 29, 2019)**

- \$22.00 to: Morgan County Judge of Probate (includes certified copy)

## Insolvency

- Court Costs assessed after the final hearing
  - \$143.50 x 2 (two separate checks payable to Hartselle Enquirer for publication)
- 

## Exempt Property (Homestead Exemption, Family Allowance, & Personal Property Exemption)

- \$40.00 to: Morgan County Judge of Probate

## Drafting Order

- \$10.00 to: Morgan County Judge of Probate

## Docketing Cause

- \$10.00 to: Morgan County Judge of Probate

## Partial/Final Settlement of Guardianship/Conservatorship

- \$20.00 to: Morgan County Judge of Probate
